The Consumer Affairs Committee of Division 2 (Antitrust, Trade Regulation and Consumer Affairs) proposes that the <u>Daily Washington Law Reporter</u> commence publication of the Orders issued by the Administrative Law Judge of the D.C. Department of Consumer and Regulatory Afrairs. These orders constitute an important and growing body of local jurisprudence in the consumer law area, but at present they are inadequately publicized. Publication would help draw the Bar's attention to DCRA, to consumer law and to the opportunities for enforcement of consumers' rights.

Dear Editor:

I write to draw your attention to an important but under-utilized body of law in Washington, D.C. that deserves publication in the <u>Daily Washington Law Reporter.</u> 1

The D.C. Department of Consumer and Regulatory Affairs (DCRA) is the principal local agency for enforcement of the city's stringent consumer protection legislation. DCRA's procedures include investigation, negotiation and ultimately a full-scale, adversary-type administrative hearing before an administrative law judge. The current ALJ, the Honorable Sharon T. Nelson, has issued approximately 25 Orders during the two years, averaging about 7 pages typed, doublespaced.

These orders constitute an important, growing body of D.C. jurisprudence. They are valuable resources for local practitioners, but they are difficult to locate, and are not
