Viewing the Schedule & Accessing Sessions

To browse the schedule and participate in individual sessions, log in to the event portal and then click on the Sessions tab on the left navigation menu.



The sessions are listed in chronological order – scroll to view all sessions or use the search or filter options at the top of the list.

Click on the individual sessions to access the description, speaker information, and session-specific chat. The session video stream will begin at the scheduled time.

Use the chat function on the right side of the screen to ask questions and add your comments.

Exploring the Virtual Exhibit Hall
