**Michelle Beneke**, Senate Homeland Security & Governmental Affairs Committee

**Megan D. Browder** is the deputy attorney general for the Legal Counsel Division in the Office of the Attorney General for the District of Columbia (OAG). She previously was senior counsel to the Attorney General. Prior to becoming senior counsel, Ms. Browder was an assistant attorney general in OAG's Office of the Solicitor General. As an appellate attorney, she represented the Attorney General and several District agencies before the D.C. Circuit and the D.C. Court of Appeals. Her practice included a wide range of legal topics, including administrative law, employment discrimination, and constitutional law.

Ms. Browder draws on several years of litigation experience as well. Prior to joining OAG, she practiced at a boutique litigation firm with a mix of trial and appellate work. Her clients included financial institutions, private corporations, nonprofit organizations, and individuals. Ms. Browder served as a law clerk to the Hon. Allyson Duncan at the US Court of Appeals for the Fourth Circuit and then the Hon. James Boasberg at the US District Court for the District of Columbia. She is a graduate of Columbia University and Yale Law School.

**Christiane Cardoza Brundage** is an attorney in the United States Department of Health and Human Services, Office of the General Counsel, Legislation Division. Among her previous roles, she spent five years as a member of the federal policy team for the State of Hawai'i Office of Hawaiian Affairs and three years in various roles, including as counsel, in the United States Senate.

oversight activities of the Committee, as well as on legal and procedural matters that impact the Committee's work. Previously, Sarah was senior counsel to Senator Claire McCaskill, serving on both the Senate Homeland Security and Governmental Affairs Committee and the Permanent Subcommittee on Investigations. Prior to that Sarah worked on special projects and constituent issues in the office of Senator Jeff Bingaman.

Before coming to Capitol Hill in 2009, Sarah was a prosecutor in her home state of New Mexico. Sarah received her JD from the American University, Washington College of Law, and her BA in history from Boston College.

**Michael L. Goad** began his appointment as assistant general counsel (legislative counsel) with the Office of the General Counsel, US Department of Homeland Security, in 2016. Mr. Goad oversees the legal practice that is responsible, chiefly, for the development of that agency's legislative proposals.

Over the course of the last thirty-five years, he has held a variety of legal appointments and non-legal appointments with the US Department of Homeland Security, the US Office of Government Ethics, the Office of Management and Budget, the US Department of Justice, and the US Department of Transportation.

In over twelve years with the Committee, she worked on a wide range of legislative and oversight matters, including the bill that enacted the recommendations of the 9/11 Commission, a report on the failed response to Hurricane Katrina and the resulting legislation to strengthen FEMA, an investigation into the collapse of Enron Corp., legislation streamlining the process for nominating and confirming presidential appointees, and efforts to reform the US Postal Service.

Ms. Grossman began her career with the federal government as an attorney in the Bureau of Consumer Protection at the Federal Trade Commission, where she handled

false advertising cases and started the FTC's program to assist victims of identity theft. She is a graduate of Brown University, Harvard Law School, and the Harvard Kennedy School.

**Michelle Johnson-Weider** is an attorney in the United States Department of Health and Human Services, Office of the General Counsel, Legislation Division. She previously spent three years as a program analyst for SNAP certification policy at the Food and Nutrition Service and thirteen years in the United States Senate Office of the Legislative Counsel, where she had primary responsibility for drafting legislative proposals relating to agriculture and nutrition.

From 2020 – 2022, she co-taught a spring class in legislative analysis and drafting at the George Washington University Law School in Washington, DC. Michelle earned her BA in anthropology from the University of Florida and her JD from Stetson University College of Law. In December 2019 she received her LLM in agricultural & food law from the University of Arkansas School of Law.

Michelle is a member of the California, District of Columbia, and Virginia bars, and is admitted to practice before various federal courts of appeals and the Supreme Court

of the United States. Michelle serves as a mentor for The Appellate Project and is also a founding member of the Ad Idem Corporate Counsel Network, the Washington Area Women Trial Attorneys, and the Women Lawyers on Guard. She earned her JD from Vanderbilt University School of Law, and a BA from Stanford University.

He served as the senior counsel to vice chair Liz Cheney. In this role, he developed investigative strategy, conducted investigative interviews and depositions, assisted with litigation in more than twenty lawsuits filed against the Select Committee, prepared members for hearings, and drafted portions of the Select Committee's final report.

Mr. Maher graduated with honors from both the University of Chicago Law School, where he served on the *University of Chicago Law Review*, and Northwestern University (earning a degree in materials science and engineering).
