

D.C. BAR COMMUNITIES
2026-27 ELECTION AND CAMPAIGN RULES

Deadlines/Important Dates:

- Candidate Interest Form due – **January 30, 2026, 11:59 p.m. – NEW DATE**
- Candidate vetting – February 2 – February 26, 2026
- Candidates notified of selection to slate – February 27, 2026
- Candidates begin submitting bios/statements/photos to election website – February 27, 2026
- Last date for candidates to submit bios/statements/photos to election website – **March 20, 2026 – NEW DATE**
- Voting begins – April 15, 2026
- Voting ends – June 3, 2026
- Candidates, public notified of results – June 8, 2026

Eligibility (for steering committee candidates and voters):

- Candidates and voters must be a member in good standing (active, inactive, or judicial) of the D.C. Bar by March 1, 2026.
- Candidates must be a member of the community for which they seek office by March 1, 2026.
- Voters must be a member of the community for which they seek to vote by March 1, 2026.
- Subscribers (D.C. Bar non-members who are Communities members) ARE NOT ELIGIBLE TO VOTE
- Eligible voters will receive a ballot tailored to their Bar and Communities memberships.
- Candidates may seek election to the steering committee of any community of which they are a member but are strongly encouraged to limit candidacies to two or fewer communities during an election cycle. This promotes greater volunteer opportunities for more members and limits unserious candidacies.

Campaigning:

- Listservs
 - Candidates for Communities steering committees may use the listserv for the community for which they are seeking office once per election period.
 - Candidates for other D.C. Bar offices (Bar officers, BOG) may use the listserv for any community to which they belong once per election period.
 - ALL CANDIDATES contemplating use of any community listserv for campaign purposes must consult with staff at communities@dcbar.org at least 48 hours before use to help control traffic on the listservs. ALL CANDIDATES must wait for a response from staff before using the listserv for campaigning.
 - All messages to the listserv must include “Please do not reply all to this message” above all other content.
 - Candidates are allowed to tout their own qualifications and experience for the position for which they are running and must refrain from commenting on other candidates’ background.

- Only candidates may send campaign messages to the listservs; there should be no campaigning on others' behalf on the listservs.
- Listserv use is a privilege, and users should practice decorum and civility in their communications, or the privilege may be lost.

- Networking:

Feel free to communicate with your firm, organization or agency colleagues. Remember that all individuals must be a member of the community for which you are running to vote for you. Individuals who are members will receive a ballot tailored to their Bar and Communities memberships.

- Communities Office Promotion:

The D.C. Bar Communities Office will provide several announcements indicating the slate of candidates immediately before and during the election period.
