The Section recognizes that many persons in the District of Columbia who live together are not part of a "traditional" family of mother, father, and children living together. many persons in nontraditional families together raise children, have other dependents, own homes and other property, commutes and plan for a long life and future with each other, just as "traditional" families do. "traditional" Both nontraditional families strengthen the fabric of society by Abbrary and Veterious Regime providing emotional relationships and mutual sharing that give meaning and stability to family members as they confront increasing stresses of life. However, only the "traditional" family currently enjoys the full protection and benefits of many District of Columbia laws.

The Health Care Benefits Expansion Act of 1992 recognizes the existence and value of domestic partners who have a familial relationship characterized by mutual caring and the sharing of a mutual residence. The Act does so by providing for the registration of domestic partners; prohibiting discrimination against domestic partners in visitation rights at health care facilities; allowing sick, funeral, parental, and adoption leave for District government employees who must attend to the needs of their domestic partners and family members; provding for employeefinanced health insurance coverage for the domestic partners and family members of District government employees; and allowing a tax deduction for private District employers who choose to offer health insurance for the domestic partners and family members of their employees.

The Health Care Benefits Expansion Act of 1992 is an important step in affording rights to many residents of the District of Columbia. The Act is a lawful and admirable exercise of Home Rule by the District of Columbia. The Section urges the Congress to permit the Act to become law.
